The concerned Institution should verify the original certificates of the candidate. Wherever PH or VH appears in the UGC Ref. No., the relevant documents of Physical or Visual disability should be checked. It should also be verified whether the candidates fulfill the minimum eligibility conditions for Junior Research Fellowship, i.e., at least 55% marks in Master's Degree (or) equivalent examination from a University/Institution recognised by UGC for General/OBC and 50% for SC/ST/PH/VH candidates within two years from the date of declaration of UGC-NET result.

The candidate should not be more than 28 years of age as on the first day of the month of the concerned UGC-NET (i.e., 01/06/2010), relaxable by five years for SC/ST/OBC/PH/VH and female candidates. Relaxation in age up to 3 years is provided to candidates who have done LLM and to research scholars for the period of research. Total relaxation on the above ground(s) can not exceed five years.

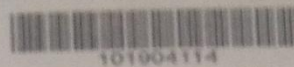
